Welcome! So, the VESBA project is now entering Year 4, and we have had even more landowners signing up to take part. Designed to explore the success factors for a large-scale, farmer-led, badger vaccination scheme, the Defra-funded project has not only been vaccinated badgers across 250 km<sup>2</sup> of East Sussex - we have also been able to support vaccination on farms in Kent and Surrey. Spreading the word is also important, and members of the team have attended shows and given talks to farmers and vets, using our practical experience to answer questions about badger vaccination.



With the 2024 season beginning on 1<sup>st</sup> May, the team have been out pre-baiting rounds with peanuts from the middle of April onwards - and the efforts were duly rewarded - with 37 badgers vaccinated on the first morning alone! With more rounds ongoing, we have already vaccinated over 160 badgers in Year 4.

## **Training Update**

In another development, Chris Tuckett has successfully completed a course to enable him to be able to train others to cage trap (Module 2) and vaccinate badgers (Module 3).



Until recently, training could only be delivered by APHA staff, who had to travel a fair distance to East Sussex. For anyone that has had to organise a training event, you can understand that it can be difficult to co-ordinate the venue, the trainer and the attendees - but for vaccination training, you also need to factor in the weather (as traps cannot be set if the forecast is poor). The final element is making sure that there will be enough badgers trapped to enable the trainees to vaccinate at least four animals each—which is why the course is limited to two people. Prior to the 'field' element, there is also a classroom session that covers the legalities around badger vaccination, as well as how the vaccine needs to be stored and reconstituted. If you, or someone you know, might be interested in completing this training, please contact Laura Anderson.
